The Ljubljana Arbitration Centre (LAC) is an autonomous arbitration institution that operates independently at the Chamber of Commerce and Industry of Slovenia. We have been settling disputes since the establishment of the Tribunal of the Ljubljana Chamber of Trade, Craft and Industry in 1928.

The LAC administers the resolution of domestic and international disputes through arbitration, mediation, conciliation and other forms of alternative dispute resolution in accordance with its rules and other rules and procedures agreed by the parties. More than 40% of all cases brought before the LAC are international disputes, i.e. disputes involving at least one party not based in Slovenia.
